New Business

1.Watutco Water Service:

- Bruce Green, Assistant Fire Chief for the Black Creek Oyster Bay fire service stated that the residences served by this system have adequate fire protection. The trucks are capable of carrying enough water to fight fires and, if need arises, have access to the Comox Valley Regional District water supply.
- Ann MacDonald, Manager of Strategic and Long Range Planning for the CVRD is organizing a meeting for people served by the Watutco water system to discuss any concerns. - **3. Saratoga & Miracle Beach Local Area Plan**: Phase 2 Consultation with CVRD Staff and OCP / LAP Review Consultant: Ann MacDonald and consultant Chris Hall explained that the Official Community Plan is being revised to align with the Regional Growth Strategy (RGS) completed in 2011. The RGS contains policies to guide growth and development in the Comox Valley Regional District. The SAMBRA area has been designated a settlement node; the purpose of this meeting's consultation and earlier consultations with residents is to develop a Local Area Plan.

After this consultation, the objective is to return to this area in late May with draft policies for further review and discussion followed by a public hearing in late summer. The Official Community Plan is expected to go before the Comox Valley Regional District Board for approval in October.
